

## **SPECIFIC RULES FOR THE TRANSPORT OF INFANTS ON CABLE CAR SYSTEMS OPERATED BY SESTRIERES S.p.A.**

The transport of young children (infants aged 0 to 24 months) is permitted only with their parents on the cable cars that carry pedestrians, as indicated in the "Lift opening schedule".

Young children in early infancy must be transported by a parent (a parent may transport one young child only), using a safety harness that holds the child to the parent's body (e.g. "baby carrier"), on the front of the torso. The child safety harness must not interfere with the closing of the vehicle safety bar (in the case of transport by chairlift) and must not create situations of potential danger for other passengers in the same vehicle.

Responsibility for transporting a young child is always the sole responsibility of the parent, who must consider the health and characteristics of the infant, the suitability of their clothing and the equipment used for the trip, also taking into account the weather conditions, altitude, the possible stoppage of the lift, the possible evacuation of passengers from the line in the event of a breakdown - blockage of the lift. The parent must take all necessary precautions and watch out for their own safety, that of the infant being transported and of third parties.

Access to cableways with infants is subject to the accompanying parent's possession of a ticket and the acquisition of a free ticket for the infant.

### **HEREBY DECLARE THAT**

- I exercise parental authority over the infant identified above;
- I have read and fully accept the specific rules governing the transport of infants on the above-mentioned cableways;
- the infant restraint system used for the trip is completely safe. It complies with the specific technical standards of the sector and meets the requirements of the operating methods indicated above (positioning on the front of the parent's torso and absence of interference with the opening and closing of the safety bar, in the case of transport by chairlift);

- I undertake to comply strictly with the instructions given by the staff in charge of operating the cableway system, observing the specific instructions given to ensure the respect of the safety of the transport system and of the passengers transported;
- the infant travels under my full responsibility and I undertake to indemnify the operating company and any third parties for any damage caused during the journey;
- I am aware that the cableway is located in a mountainous area, at a high altitude, with weather conditions that may be harsh for passengers and particularly infants;
- I am aware that, if the cableway becomes blocked due to a failure or for other causes (power failure, strong wind, etc.) it may be necessary to spend several hours in the cable car, during which I undertake to ensure the safety of the infant while waiting for the system to restart or to be evacuated from the line;
- I am aware that, if the system cannot restart due to failure or other causes, procedures will be activated by the rescue service to evacuate passengers from the line, lowering them to the ground on a rope. The descent of the small child will be carried out by authorised personnel according to the procedures set out in the specific rescue plan and in relation to the type of restraint and safety harness used by the parent.

The accompanying parent undertakes to comply with the “Specific rules for the transport of infants on cable car systems” operated by Sestrieres S.p.A.’ as disclosed above, assuming full responsibility.
